FIRST ORDER OF BUSINESS

Call to Order

Mr. Williams called the meeting to order and read the roll call.

SECOND ORDER OF BUSINESS

Consideration of Minutes of the Board of Supervisors' Meeting on April 20, 2004

Mr. Williams asked if there were any additions, deletions or corrections to the minutes. Hearing and seeing none, he asked for a motion to approve.

THIRD ORDER OF BUSINESS

**Consideration of Authorizations
to Disburse District Funds 2004-08
and 2004-08A**

Mr. Williams stated that the next item on the agenda was the consideration of the Authorizations to Disburse District Funds 2004-08 and 2004-08A (located behind tab 2). He stated that disbursement 2004-08 consists of invoices for standard contractual obligations, legal fees and management fees. Mr. Williams explained that Disbursement 2004-08A pertains to contractual obligations for the amenities center. He asked if there were any questions. There were none, so he asked for a motion to approve.

On MOTION by Mr. Whyte, seconded by Mr. Coughlin, with all in favor, the Board approved the Authorizations to Disburse District Funds 2004-08 and 2004-08A for Harbor Bay Community Development District.

FOURTH ORDER OF BUSINESS

**Consideration of Series 2002
Construction Requisitions #253-#260**

He explained that the requisitions have been reviewed and certified by the District Engineer, with the exception of #258 which is awaiting certification. On MOTION by Ms. Kunkel, seconded by Ms. Wrenn, with all in favor, the Board approved Series 2002 Construction Requisitions #253-#260 for Harbor Bay Community Development District.

On MOTION by Mr. Coughlin, seconded by Ms. Kunkel, with all in favor, the Board approved the proposal for Kim's Landscape & Waterfall Creations, Inc. totaling \$ 265,200.00 for Harbor Bay Community Development District.

Mr. Williams stated that the next item for discussion is the ratification of a TECO Street Lighting Agreement (pertaining to the installation of outdoor street lighting for Parcel 5B) which was previously authorized by the Board. Mr. Williams asked for a motion to ratify the agreement.

On MOTION by Mr. Whyte, seconded by Ms. Coughlin, with all in favor, the Board ratified the TECO agreement (Parcel 5B) for Harbor Bay Community Development District.

Mr. Williams asked if there were any questions or comments. Ms. Kunkel stated that the proposal for Kim's Landscaping would not include signage.

Mr. Coughlin stated that the salon and two saunas are anticipated to be completed by Friday. He stated that the pool slide is expected to be available for use shortly. The Health Department inspection will be scheduled this week.


There was a discussion regarding the opening of the pool in time for the Memorial Weekend.
